

## **Participant Request for IDX Display on Participant/Sales Licensee Websites (“Participant Request”)**

In consideration for the License granted by MLS to Vendor with respect to Your Website, You agree to pay to MLS the license fees, if any, as set forth for Participant Websites in the License Agreement.

You represent and warrant to MLS that (1) You are a principal real estate broker, broker in charge, or a real estate brokerage firm (“Participant”), licensed in accordance with the laws of the state of Nevada; (2) You are a Participant in good standing to GLVAR’s Multiple Listing Service; (3) You are a participant in MLS’s Internet Data Exchange (IDX) program as described in the Rules and Regulations; and (4) You are not in default under the Rules and Regulations. You represent and warrant that development and operation of Your Website will at all times be under your direct supervision and control.
